General Data Protection Regulation 2018

The General Data Protection Regulation came into force on 25 May 2018 and Eden Christian Trust is committed to operating within it and protecting your personal information. The Regulation requires that we identify our legal basis for the processing of personal data. We have one main basis: that the holding and processing of data about members is necessary for the legitimate interests of the Trust.
